95. Task groups & Working Parties

Highways – Councillor Dalton

Flooding

Councillor Dalton reported incidents of flooding including the top of St Martins Road from Droylesdon Park Road. Green Lane at the junction caused by run off from the Kings Hill fields. The gully from the Primary School towards Green Lane was blocked and needed clearing.

ACTION: Issue to be reported to Coventry City Council Highways Department.

• Kings Hill – Councillor Mrs Fryer

It was reported that since the last meeting, Savilles, one of the Consortium of developers had put in an addendum to the outline planning permission. Residents and organisations that had submitted responses to previous applications received notification from WDC. CCC had not informed the Parish Council but had placed a notice in the Coventry Telegraph.

Lucy Hammond from WDC informed the Parish Council that there were no alterations to the original submission. The wording had changed to include extra categories for commercial and retail outlets eg fast food takeaways and a bank.

The Kings Hill Group had studied the Addendum and noted that the proposed roundabout at the junction of Green Lane/St Martins Road had been reduced in size.

The alteration does not take into account any of the previous concerns that a roundabout was totally inappropriate. The Group had felt that if residents did not submit their views again it could be taken that the proposal was now acceptable.

Accordingly, the group had contacted all residents on the email database and also placed information on the website and Pride in Finham.

The deadline for responses to WDC was 21st November but CCC was 28th November 2019.

A copy of the letter and information had been sent to Andy Street, West Midlands Mayor via Cllr Allan Andrews. An email response had been received.

The heavy rains of last week resulted in flooding in the area where the roundabout was proposed. This occurred with the fields remaining on Kings Hill. Councils needed to consider the impact of heavy rains when 4,500 houses replace the fields.

Traffic along St Martins Road and Green Lane continued to be a problem and the A45 was now being used far more by heavy vehicles. This had become a daily occurrence now and CCC should be taking this into account when looking at the Developer's outline plans.

Schools – Councillor Mrs Bush

It was noted that the children had been enthusiastically collecting items for donations to be made to the Food Bank which is a worthwhile cause. This week it had been Road Safety Week and the children had been made aware of safety issues when crossing the road etc.

As part of the build-up for Christmas the children would be going on two trips. The Nursery and Reception – Warwick Arts Centre and Years 1-4 to the Belgrade Theatre.


Coventry City of Culture – Councillor Ms Taylor

For the Finham / Green Lane area there were a total of 13 crimes. 4 of these are at the BP garage.



Year to date figures January –September 2019 show a 33% drop.

Tony Swann is developing a Crime Index which will enable us to see our area compared to other areas in the city in a more accurate way. Comparing crime figures per population of an area.
