## 55. Governance

## 55.1 Standing Orders and Financial Regulations

Due to the Parish Council not holding the Annual Parish Council meeting in May 2020, the Standing Orders and Financial Regulations were not discussed.

## Highways – Councillor Morshead

Councillor Morshead updated on the previously reported pot holes. The ones situated in Daleway had been inspected by CCC who confirmed they didn't require fixing, however they had been repaired today.

Pavements in The Greylands – it was noted that the pavements in The Greylands were only laid last year but they were already breaking up.

## Kings Hill – Councillor Davies

As everyone knows by now, the Rt. Hon. Robert Jenrick, Secretary of State for Housing, Communities and Local Government (SoS) has refused to 'call in' the planning permissions produced by both Warwick District Council (WDC) and Coventry City Council (CCC) for Kings Hill as it is considered important and necessary that local decisions should be taken at local level which puts us all in the hands of WDC and CCC.

Nowhere in the whole of the Midlands is there a population projection increase anywhere near 32% so it is perplexing to residents, Resident Associations and Parish Councils, why those in our local councils stubbornly refuse to listen and understand the protestations of so many of the local people and organisations most affected by the developments all around Coventry, including Kings Hill.

Out of interest, since 2014 when this projection was made, the population of Coventry has grown by just over 6% and therefore we face the prospect of a further increase of 26% in the next 10 years! This of course assumes that the Office for National Statistics (ONS) is correct with its projections for Coventry.

On Saturday 22nd August, there was an article in The Times about Kings Hill. CCC is shown in a bad light and so is the ONS. In this article - "A spokes woman for the ONS said that ministers had given no sign of doubting the projections. 'All of our methods have been explained to be fully transparent and helpful' she said".

These are the experts we pay to carry out a thorough job especially when standards of living are threatened.

I think it fair to say that The Times is still considered to be the fairest and most even handed of all our national newspapers. As they say — There are none so blind as those who will not see. Which loosely translated means the most deluded people are those who choose to ignore what they know already.

We live in an age where "experts" are distrusted. In this case it is the ONS. This is yet another example where "experts" are not to be trusted.

Most of us have heard of the Governments new proposed rules for building for the future which are designed to reduce the time it takes for building projects to proceed. It is very doubtful that these new rules will suit those most affected by new housing estates.

A cursory glance suggests a developers' charter to ensure the government's target of 300,000 houses a year is achieved.

For the rules to appear fair for all parties and not just developers and local councils who cannot interpret accurately ONS projections and not taking into account local conditions, there must be organisations representing the local residents who are the ones most affected. It is revealing to know that the Campaign to Protect Rural England (CPRE), a national organisation, applied to be party to discussions on the formation of rules but were denied. So, who under these new enlightened rules is there to protect the ordinary person in the street.

One of the comments in the draft for the new policy is "Valued green spaces and Green Belt will continue to be protected for future generations, with the reforms allowing for more building on brownfield land". Such statements really do not convince in their sincerity after what has happened to Kings Hill. There are still brownfield and greenfield sites within Coventry boundaries which are not being touched.

The SoS had a perfect opportunity to show he was sincere when he was able to scrutinise the reports and comments made about Kings Hill. Who on earth believes the population projections of a 32% increase for Coventry made by the ONS. Apparently, the SoS does not see this discrepancy worth intervening for on behalf of Coventry citizens.

What is needed is a process which allows those affected by huge housing developments to have some influence on decisions and for 'experts' to listen and act in accordance with the majority of opinion expressed.

On Tuesday 8<sup>th</sup> September 2020 Gary Ridley, Leader of the Conservatives on CCC who oppose the Kings Hill development, gave a speech to an assembled crowd outside the Council House before he presented two petitions totally 6,500 signatures to the CCC, expressing concern about the removal of greenbelt land all around Coventry based on the now infamous 32% population projections produced by the ONS.

He was not hopeful of any success resulting from the petitions but they highlighted how wrong the CCC were in this matter and that it is the current council that is wholly responsible, as well as for Kings Hill.

Gary stated that the best hope now lay with the review of the CCC Local Plan muted to be in March 2021 but he did not sound confident that such a review would happen.

Consequently, it is up to us all to keep up the pressure on the CCC and hold this very much needed review before too much needless destruction has taken place.

## **Road markings**

It was reported that road markings had appeared on Green Lane but their origin could not be established.

#### Schools – Councillor Mrs Bush

Councillor Mrs Bush reported that the children had returned to school at the start of the term. All possible precautions were in place to ensure the children, teachers and staff safety.

The school had written to parents raising the concern that parents were not social distancing during drop off and pick up time.

Concern was expressed that some classes were not "in a bubble", one class had been taught by 4 different teaches in the same week. It was also thought that the same PE teacher taught the whole school.

**ACTION**: Councillor Mrs Bush would raise the concern and seek confirmation at the next Governors' meeting.


## Coventry City of Culture – Councillor Ms Taylor
